

#### Use, storage and stability

The working concentration of the product in organoid cultures should be determined experimentally. As a starting concentration 1 % can be used <sup>1)</sup>.

The product should be stored at -  $80 \,^{\circ}$ C (stable for at least 1 year). After thawing it should be stored in appropriate small aliquots at -  $20 \,^{\circ}$ C or -  $80 \,^{\circ}$ C (stable for at least 2 months) or at  $4 \,^{\circ}$ C for short time storage.
